




**INSTRUCTION MANUAL** 



# CONTROL PANEL / PANEL DE CONTROL / PANNEAU DE COMMANDE

### DESCRIPTION

- 1. METAL COVER GRILL: Helps reduced noise with the built-in pop/wind filter.
- 2. HIGH FEDELITY MICROPHONE: Using advanced guide noise suppresion, it can effectively reduce unwanted frequencies. Its unique design helps stabalize the direct sound and optimizes the signal for a good quality singnal reproduction.
- 3. RECIEVER: Uses a rechargeable Lithium-ion replaceble battery for long life and usage. The receiver uses a 6.35mm male TS connector type for an easy connection with a range of 30-50 meters.
- 4. ULTRA-HIGH FREQUENCIES: This mic operates in the 700Mhz bandwith.
- 5. INFRARED FREQUENCY: The system uses the infrared frequencies to sync the mic and receiver automatically. This makes it possilbe to work instantly.
- 1. REJILLA DE CUBIERTA DE METAL: ayuda a reducir el ruido con el filtro de viento / pop incorporado.
- 2. MICRÓFONO DE ALTA FEDELIDAD: al utilizar la supresión de ruido de guía avanzada, puede reducir eficazmente las frecuencias no deseadas. Su diseño único ayuda a estabilizar el sonido directo y optimiza la señal para una reproducción única de buena calidad.
- 3. RECEPTOR: utiliza una batería reemplazable de iones de litio recargable para una vida útil y un uso prolongados. El receptor utiliza un conector tipo TS macho de 6.35 mm para una fácil conexión con un alcance de 30-50 metros.
- FRECUENCIAS ULTRA ALTAS: este micrófono funciona en el ancho de banda de 700Mhz.
- 5. FRECUENCIA DE INFRARROJOS: el sistema utiliza las frecuencias de infrarrojos para sincronizar el micrófono y el receptor automáticamente. Esto hace que sea posible trabajar instantáneamente.
- 1. GRILLE DE PROTECTION EN MÉTAL: aide à réduire le bruit grâce au filtre anti-pop/vent intégré.
- MICROPHONE HAUTE FRÉQUENCE: grâce à la suppression avancée du bruit de guidage, il peut réduire efficacement les fréquences indésirables. Sa conception unique permet de stabiliser le son direct et d'optimiser le signal pour une restitution sonore de bonne qualité.
- RÉCEPTEUR: Utilise une batterie rechargeable au lithium-ion remplaçable pour une longue durée de vie et d'utilisation. Le récepteur utilise un connecteur de type TS mâle de 6,35 mm pour une connexion facile avec une portée de 30 à 50 mètres.
- 4. ULTRA-HIGH FREQUENCIES: Ce micro fonctionne dans la bande passante 700Mhz.
- 5. Fréquence infrarouge: Le système utilise les fréquences infrarouges pour synchroniser automatiquement le micro et le récepteur. Cela permet de travailler instantanément.

#### USING THE MIC. UTILIZANDO EL MICRÓFONO. UTILISATION DU MICROPHONE.

- 1. Load a (AA) battery into the microphone (5) and turn ON the Mic by pressing the ON/OFF button.
- 2. Turn on the receiver and connect it to the Mic Input port on the corresponding unit.
- 3. Turn the Mic volume up on the corresponding unit.
- If the signal sound scratch try changing the frquency channel (4) found in the microphone battery compartment.
- 1. Coloque una batería (AA) en el micrófono (5) y encienda el micrófono presionando el botón ON / OFF.
- 2. Encienda el receptor y conéctelo al puerto de entrada de micrófono de la unidad correspondiente.
- Suba el volumen del micrófono en la unidad correspondiente.
- Si el sonido de la señal se raya, intente cambiar el canal de frecuencia (4) que se encuentra en el compartimento de la batería del micrófono.
- 1. Insérez une pile (AA) dans le microphone (5) et allumez le micro en appuyant sur le bouto ON/OFF.
- 2. Allumez le récepteur et connectez-le au port d'entrée micro de l'unité correspondante. 3. Augmentez le volume du micro sur l'unité correspondante.
- \* Si le signal sonore gratte, essayez de changer le canal de fréquence (4) trouvé dans le compartiment des piles du microphone.
