If the battery casing is dismantled, small amounts of electrolyte may leak. Collect all released material in a plastic lined container. Dispose off according to the local law and rules. Avoid leached substances to get into the earth, canalization or waters.

## 7. Handling and storage

### (a) Precautions for safe handling

Always follow the warning information on the batteries and in the manuals of devices. Only use the recommended battery types. Keep batteries away from children. ## 14. Transport information

For stopovers, the vehicle should be away from fire and heat sources. Under the condition of Road Transportation, the driver should drive in accordance with regulated route, don't stop over in the residential area and congested area.
